A Healthcare Tool for Your Peace of Mind

TCCH is offering Remote Patient Monitoring (RPM) to patients with congestive heart failure and those with a combination of diabetes and high blood pressure. RPM eligibility is based on individual medical diagnosis.

If you qualify for RPM through TCCH, our partner Accuhealth, will mail the appropriate equipment to your home at no cost to you. Once delivered, they will call with simple training on how to use the equipment.



Stay Connected to Your Provider

Remote Patient Monitoring transmits your information via Bluetooth technology while you stay comfortable in your own home. You do not need a cell phone to participate.

Licensed nursing professionals review the data 24 hours, seven days a week to monitor your health, make recommendations and follow up on high risk or critical values.

If a critical or abnormal value occurs, TCCH licensed nursing staff and medical providers will determine a course of action. This may include a visit to your medical provider, change in medication or instructions to go to the hospital.
